

# Raffle "WIN Symposium 02.7.2023" Terms and Conditions

The promotor of this raffle and supplier of the Prize is Institut Straumann AG, a company registered in Switzerland with its registered office address at Peter Merian-Weg 12, 4052 Basel (Straumann). By having registered to the virtual symposium WIN Global online Symposium 2023 "Your implant journey: from basics to beyond" and consented to participate in this raffle you are agreeing to be bound by these terms and conditions, which have been made available to you on the internet page Campus Live, where you registered to attend.

By having registered and consented to participate in the raffle you have a chance to win the following prize:

Prize: One registration to the ITI World Symposium 2024 taking place between May 9-11, 2024 in Singapore. In total 10 registrations will be raffled.

## 1. Eligibility

- a. Except for employees of Straumann Group, their families, agents or third parties directly associated with administration of this prize draw, the raffle is open to:
  - i. all attendees over the age of 18 and
  - ii. who are actively practicing dental professionals and
  - iii. have registered and attended the virtual "WIN Symposium" in the period from June 9 to July 2nd, 2023 live or watched the content on demand and
  - iv. have given their consent to participate in this raffle.
- b. Straumann reserves the right to verify the eligibility of all entrants at any time, and may in its sole discretion deny eligibility to any entrant at any time.

### 2. Prize Draw

- a. The raffle participation is free and independent from any past or potential future use of Straumann products.
- b.Entry to the raffle will **start** 09.06.2023, until 02.07.2023 Midnight Basel Time. ("**Closing Time**") unless Straumann notifies you otherwise. On demand attendance registered and completed after the Closing Time will not be accepted by Straumann.
- c. By entering the raffle, you hereby warrant that all information submitted by you on the registration is true, accurate, current, complete, and not misleading.
- d.Straumann reserves the right to disqualify any entrant if it had reasonable grounds to believe the entrant has breached any of the terms and conditions set out herein.
- e. Raffle entries cannot be cancelled.
- f. Straumann accepts no liability for registrations which are not complete or delayed.
- g. The winners will be chosen by a random draw.

#### 3. The Prize

- a. The winners of the raffle will receive the Prize and no alternatives or cash prizes are given.
- b. The Prize is non-exchangeable, non-transferrable and for use by the winner only (subject to these terms and conditions).
- c. The Prize does NOT include any additional costs or expenses (such as hotel accommodation or travel to congress destination etc.) other than the Prize detailed above.

#### 4. The Winner

- a. The winner will be chosen by a random draw by Straumann and the decision of Straumann is final. There is no appeal process, and no correspondence or discussion will be entered into by the Straumann in relation to this.
- b. The winner will be the entrant personally.
- c. The winner will be notified via e-mail from a member of the Straumann Global Medical Excellence team using the details provided on registration. If the Winner rejects acceptance of the Prize, Straumann will raffle it again and an alternative entrant will have a chance to win the Prize.



- d. The Prize may not be claimed by a third party on behalf of the entrant.
- e. The Prize will be provided to the winner on a date agreed between the winner and Straumann.
- f. Straumann will make the names (first and last name) and country the winners practice upon acceptance of the prize public on Straumann Global Social Media Channels. If you object to this information being shared in this way, please do let Straumann know. Please note that Straumann may be required by law to disclose your name and value of prize.
- g. Straumann reserves all rights to disqualify any entrant in its sole discretion and for any reason, including that that entrant's conduct is contrary to the spirit or intention of the raffle.

## 5. Ownership and use of raffle entries / data protection

- a. Institut Straumann AG will be the data controller for the processing activities detailed below and pertaining to the raffle.
- b. By entering the raffle, certain data pertaining to you will be further processed to enable your participation in the raffle, administer the raffle, allocate the prizes, and notify the winners. The personal data processed are: name (first and last name), country, profession and e-mail address. The legal basis for such processing is your consent. - c. To announce the winner and communicate it on the dedicated platform (CampusLive) we will further process your name and surname based on our legitimate interest. You can object to such processing but there may be additional delays in you being informed of your prize.
- d. Straumann may retain the personal data for as long as is necessary to achieve the purpose set out above, to comply with its legal or regulatory obligations or the defence of legal claims.
- e. Your personal data will not be shared with third parties for commercial reasons, but may be shared by Straumann with its processors for the purpose of supporting the operation of the raffle, but only as far as is reasonably necessary. Such processors are subject to binding contractual obligations to: (i) only process the personal data in accordance with Straumann's prior written instructions; and (ii) use measures to protect the confidentiality and security of the personal data.
- f. Straumann has implemented appropriate technical and organizational security measures designed to protect your personal data against accidental or unlawful destruction, loss, alteration, unauthorized disclosure, unauthorized access, and other unlawful or unauthorized forms of processing, in accordance with applicable laws. Your data will not be processed for automated individual decision-making which produces legal effects concerning you or similar effects.
- g. You have the right to request access to, deletion of, portability and object to the use of your personal data in accordance with the applicable data protection laws. Some of these rights may be limited by applicable data protection laws. You also may have the right to complain to a supervisory authority or to seek judicial remedies.
